

## Form for use in conjunction with an application for an extension of stay in Sweden

If you are in Sweden and wish to extend your stay you must complete this form. You hand in the form together with your application for a residence permit.

When you visit the Migration Board you must present your passport and a return ticket (if you have one). You must also show that you can support yourself during your stay. If someone else will be supporting you in Sweden details of his or her income must be confirmed. NOTE: he or she must also sign this form.
