- Receipt showing that you have paid the application fee.

You must also append

- Operational plan
- Market survey
- Contracts with customers/suppliers
- Contract for premises
- Any permits for the business
- Investment budget, liquidity budget, budget of profit and loss
- Budgeted balance sheet
- Bank certificates showing that you have money to maintain yourself and to finance the estimated costs of the business during the first year in Sweden.
- Certificate showing your participating interest (share record or partnership agreement)
- The two last annual accounts/annual reports if you bought a business that is already established
