If you are a citizen of a country outside of the EU/EEA or Switzerland, you can use this form to apply for a permit to work in Sweden as a seasonal worker. The permit applies to seasonal work within agriculture, forestry and tourism, in addition to other sectors. Your employer must be established in Sweden.

When applying for the first time, you must complete the application and have your permit granted before travelling to Sweden. The Swedish Migration Agency does charge an application fee to process your application.

We will be able to make a decision more quickly if you fill in all details in the form and send in all required documentation. The process will take longer if we are required to ask you to supplement your application.

Documents that you need to send in with your application

- Offer of employment (see www.migrationsverket.se).
- Statement from a trade union (see www.migrationsverket.se).
- Annex for seasonal work permit application – Accommodation details (see www.migrationsverket.se), (only if your employer rents or provides accommodation to you).
- Rental agreement or documentary evidence from landlord.
- A copy of your passport that shows your identity, the passport's period of validity and any permits to stay in countries other than your country of origin.
- Receipt which confirms you have paid the application fee.

If applying to extend your permit, then you must also send the following additional documents

- Statement of earnings with details on your income for the previous year, if you were working in Sweden then.
- Salary details for this year, if you are working in Sweden currently.
