If you have been granted a declaration of refugee status or a refugee status declaration, you can get a travel document in accordance with the 1951 Geneva Convention. If you are stateless, you can get a travel document in accordance with the 1954 New York Convention.

You must submit the application for a travel document in person at one of the Swedish Migration Agency's Service Centres. Remember that everybody applying for a travel document must come in person, including children. There is no fee for this application but an administrative surcharge of SEK 350 applies when you collect the travel document.

Note that if there are two guardians, both must approve that the Swedish Migration Agency issues a travel document for the child. If one of the guardians is staying in another country, her or his consent must nonetheless be provided to the Swedish Migration Agency.
