The application should be submitted through a Swedish embassy or consulate. An application for an extension should be submitted to Migrationsverket, Box 3100, 903 03 Umeå, Sweden.

- Documents that show the proper authorities in the child's country of origin have issued a decision on providing care
- Regulations that show which authority is competent to decide on providing care, in Swedish or English translation
- Consent for the child to be adopted, signed by the biological parents or other legal guardian
- Consent for the child to be adopted, signed by the biological parents or other legal guardian

Adoption case ongoing / adoption concluded according to the Hague convention on Intercountry Adoption

- Documents that show the adoption is in progress, or a decision has been made according to the Hague Convention. It should be clear from the document that the child has permission to stay or settle in Sweden.
- Permission of the Social Service department in accordance with Chap. 6, §6 of the Social Services Act for the parent(s) to take a child for permanent care and upbringing.
- The investigation that forms the basis for the Social Service department's permission.
- Approval for carrying out the adoption by the Family Law and Parental Support Authority (MFoF)
