Application for an extension of a residence permit

Use this form if you have previously applied for asylum or are a family member of someone who has previously applied for asylum

Fill out this form if you want to apply for an extension of your residence permit. This applies if you have previously applied for asylum or are a family member of a person who has previously applied for asylum and has been granted a temporary residence permit. If you have had a residence permit for at least three years, you can also state that you want to apply for a permanent residence permit when you apply for an extension.

Please note that you must always choose a reason for your residence permit, regardless of whether you are applying for an extension or if you are applying for a permanent residence permit.

Write in Roman letters so that it is easy for the Swedish Migration Agency to read what you have written. Fill out one form for each person, including children. If you are applying for your minor child, both custodians of the child who are residing in Sweden must sign the application. Submit the form together with all required appendices to the Swedish Migration Agency. Application for an extension of a residence permit

I wish to apply for an extension of my residence permit for the following reasons:
(You may select several reasons)

- I need protection (asylum) in Sweden
- I am a family member of a person who is resident in Sweden
- I am studying at upper secondary level in Sweden
- I want to look for work after completing studies at upper secondary level in Sweden
- I have studied at upper secondary level and can financially support myself
- I need to stay in Sweden due to particularly or exceptionally distressing circumstances.

If you are applying for an extension because you need protection in Sweden you must select one of the following alternatives:

- I have the same reasons for protection as in my previous application
- I have new reasons for protection that I have not told the Swedish Migration Agency about.

Application for a permanent residence permit

If you have had a residence permit for at least three years, you can apply for a permanent residence permit when you apply for an extension. First, state your reason for applying for an extended residence permit above.

- I want to apply for a permanent residence permit.

If you are 18 years of age or older, please tick one or more of the options below.

- I can support myself as an employee
- I can support myself as a business owner
- I am exempt from the maintenance requirement because I am entitled to a pension
- I am exempt from the maintenance requirement for other special reasons.

Documents that you are to send with your application

If you are applying for a residence permit extension because you need protection or due to particularly or exceptionally distressing circumstances, you do not need to enclose any documents. We will contact you if we need more information.

I have studied at upper secondary level and can financially support myself

If you are applying for a permanent residence permit because you have studied at upper secondary level and are able to support yourself as an employee or business owner, you must enclose the following with your application

- [Uppgifter om försörjning, form number 202011](#) (only in Swedish).

Family member

If you arrived in Sweden as a family member of a husband, wife, registered partner or cohabiting partner who applied for asylum and was granted a time limited residence permit, if you are still living with the same person, you must enclose

- [Assurance of cohabitation, form number 223011](#).

If you arrived in Sweden as a family member of a child or a parent and you wish to apply for an extended residence permit on the basis of family ties to that same person, you do not need to enclose any appendices.

If you wish to stay in Sweden because you have a new family relation (husband, wife, registered partner, common-law partner or a new-born child), you must enclose

- [Frågeformulär om nyetablerade förhållanden \(förlängning\) T78](#) (only in Swedish).

Studies on an upper secondary level

If you are applying for a residence permit because you are studying on an upper secondary level you must enclose

- an individual study plan or
- equivalent planning documents from a folk high school.

The documents that you enclose must specify the following

- that you have begun your studies
- what type of studies you are enrolled in
- that you are studying full time, or the reason for why you are studying part time
- what date your studies will be completed.

If you are enrolled in vocational training, so-called vocational package, the study plan needs to specify what vocational orientation the training has and that the purpose of the training is that you will be able to work after you have completed your studies.

Seeking employment after you have completed your studies on an upper secondary level

If you are applying for a residence permit because you have completed, or will soon complete, your studies on an upper secondary level and wish to seek employment, you must enclose

- your diploma or a certificate that shows what date you completed, or will complete, your studies.

Permanent residence permit

If you are applying for a permanent residence permit, you must enclose appendices showing that you meet the maintenance requirement or that you are exempt from the maintenance requirement. This applies only to those aged 18 and over.

- If you are employed, you must enclose an employment contract, your one to three most recent pay slips, and a document with the name, phone number and email address of a contact person at the company where you are employed.
- If you are a business owner, you must enclose documents showing that you are a business owner and what income you have from your company. For example, such documentation could be your F-tax certificate, the registration certificate for your company, your final assessment notice for the previous income year, and a copy of your income tax return (together with a copy of the NE or N3A attachment) for the previous income year.
- If you are entitled to a pension, you must submit a decision from the Swedish Pensions Agency that shows that you are entitled to an income-based retirement pension, a guarantee pension or financial support for the elderly.
- If you are exempt from the maintenance requirement for other special reasons, you must enclose documents showing that you have a permanently reduced ability to work, e.g., a decision on entitlement to sickness benefits or activity compensation from the Swedish Social Insurance Agency, an investigation from the Swedish Public Employment Service or a medical certificate.

3. Signature
