**Read this first!**

Use this form if you are not in Sweden when applying for an ICT permit to work in Sweden on grounds of a transfer within a company or group of companies and you are a citizen of a country outside the EU/EEA area and Switzerland. Your position in Sweden should be that of a manager, specialist or trainee. To obtain an ICT permit, you must be offered a salary for your job that is at the same level as that specified in the collective agreement which rules conditions within your area of occupation. Your employment conditions must also be at least equal to those of an employee stationed in Sweden.

The Swedish Migration Agency charges an application fee for processing your application.

The main rule is that you must apply for and be granted an ICT permit before you enter Sweden. Submit your application to a Swedish embassy or consulate-general. If you have an ICT permit in another EU country and intend to work within the same group of companies in Sweden, you may apply for an ICT permit for mobility for a longer stay when you are in Sweden.

If you fill in all the details in the form and enclose all the documents, you will receive a decision sooner than if we have to ask you to provide further information for your application.

- Professional statement (see [www.migrationsverket.se](http://www.migrationsverket.se)).
- Copy of passport showing your identity, the validity of the passport and any permits to remain in a country other than your country of origin.
- Examination certificate (if you are a trainee).
- Employment agreement from your employer in your country of origin.
- Trainee agreement (if you are a trainee).
- Receipt showing you have paid the application fee.

**You must send the following documents in addition, if you...****...are applying for an extension**

- Statement of earnings with details of your income for the previous year, if you were working in Sweden then.
- Wage details for this year if you are working in Sweden now.

- Copy of your current residence permit card.
